NAPIA TO HOLD 2009 MID-YEAR MEETING IN LAS VEGAS

The 2009 NAPIA Mid-Year Meeting will take place December 3-5 at Wynn Las Vegas Resort and Country Club in Las Vegas, NV. It opens with a reception at 6 pm on Thursday, December 3, and concludes at noon on Saturday, December 5.

Four hours of CE credit will be awarded to attending CPPAs and SPPAs. Applications for CE credit have also been submitted to the various state insurance departments.

The convention business agenda includes an update by NAPIA Counsel Brian Goodman, Esq. on state legal and legislative issues, as well as officer and committee reports. During the second of two evening receptions, the NAPIA Person of the Year Award will be presented to this year's recipient – Executive Director David Barrack.
